Applicants do not need to live in the South Bay but must prove that they or their ancestor(s) lived in the South Bay area before 4 July 1940 AND that they are direct descendants. (Additional categories of membership are envisioned for earlier ancestral residency.)

If a family member has been accepted into **First Families of the South Bay**, it is **NOT** necessary to duplicate his/her documentation. However, it is necessary to prove a direct-line relationship between the applicant and that person.
